**Addendum #3: Additional Clarifications on IFB
Construction Services for Transit Center Improvements**

October 25, 2019

The San Luis Obispo Regional Transit Authority has become aware that we included several mistaken/unintended pages in Addendum #2, including:

1. The "Potential DBE Firms" and "Bidder's List" were mistakenly carried over from Addendum #1. Please disregard the old "Bidder's List" replace with the attached "Revised Bidder's List." The "Potential DBE Firms" list remains unchanged.
2. Page 54 of 95 entitled "A-3 Partial Old Courthouse Site Sump Plan" should not have been included in Addendum #2. Please disregard.

In addition, we included the License Agreement on pages 71 to 95 (the last 25 pages) of Addendum #2 but provided no context. Bidders should pay particular attention to Section 9 and Section 11 of the License Agreement. Section 9 identifies coordination required between the County and the RTA (and by extension, the successful General Contractor bidder) for Utility improvements (including a minimum 10-day notice before on-site work begins). Section 11 identifies notification and inspection requirements that will require coordination among the RTA, the County and the successful bidder. Section 11 also requires the General Contractor's performance security name the County in addition to the RTA. All other sections merely identify roles and responsibilities for the County and the RTA.
