Response to Question 001: The estimate is to be on the order of \$24 million, but we will not provide line-by-line details.

**Question 002**: Is pregualification required for this job?

Response to Question 002: No. Prequalification is not required, but there is a mandatory conference call for all General Contractors interested in bidding the project. Refer to Question 003.

**Question 003**: Is the job walk going to remain as scheduled for next Thursday the 26th at 1pm with all that is going on with the Coronavirus?
