- Expect to enter service this summer

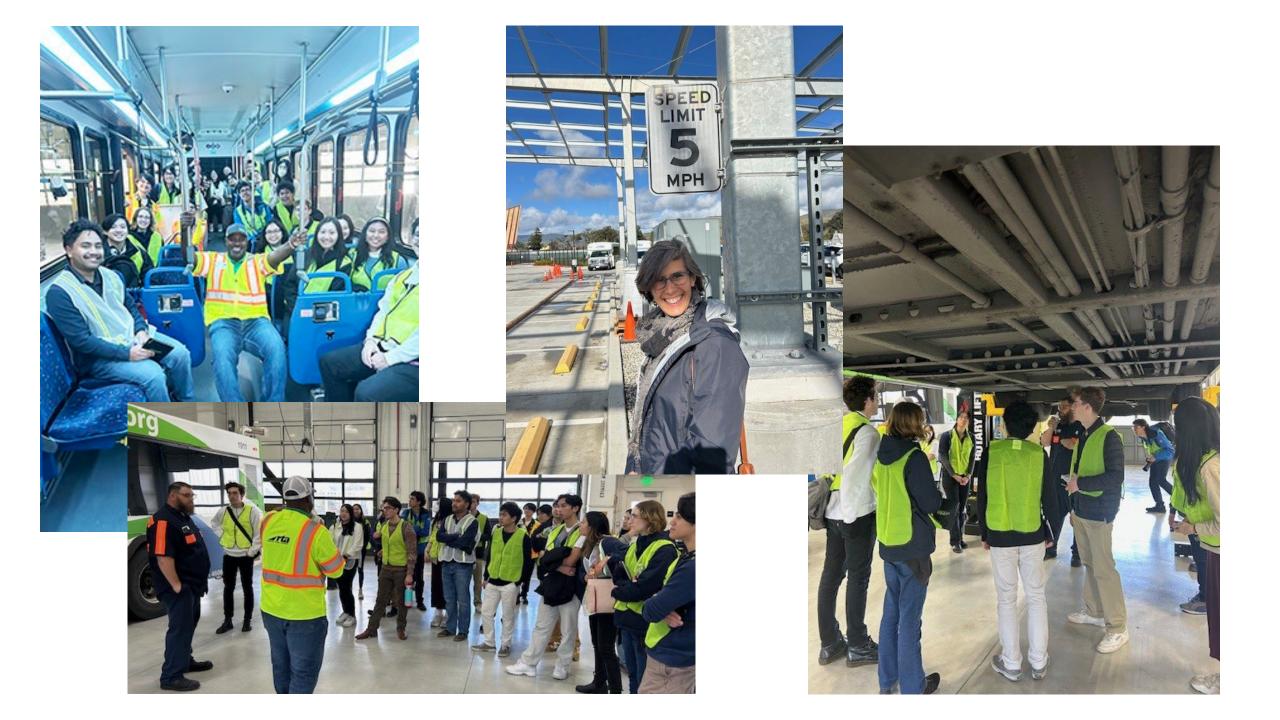




- NovaBus, Proterra & Eldorado National Corp (ENC) leaving US market
- Only two bus manufacturers remain
 - likely result in upward pressure on pricing and longer delivery times
- RTA operates three ENC buses, but they are slated for retirement when five Gillig BEBs are delivered in late 2025

- Hosted Western District ITE Student Leadership Summit
 - 100 college students
 - Tour of facility, breakout learning sessions, discussion on civic engagement, and a mini Bus Roadeo





Marketing Update

- New security settings & hosting for our website aimed at preventing attacks or other mischief

- Bus Operator recruitment ad campaign, primarily on social media channels; attracted a good pool of applicants
- RTA staff provide personalized trip plans via phone or email; respondents thrilled

- Contracted bus stop services; initial improvements at Ramona Garden Park and Templeton PnR
- Updated bus rider app
- Working with Grover Beach on the proposed Route 27 & 28 realignment
- Upcoming: BEB ribbon-cutting ceremony

Finance & Administration

- Unaudited YTD operating & financial results on page B-1-8
- RTA fixed-route ridership increased 8.9% over last year, but still 33% below pre-pandemic totals
- Runabout ridership increased 12.9%
- Past five years of ridership and productivity trends graphs are on B-1-10

- Operating costs for the fiscal year are slightly below budget at 53.8% through 58% of the fiscal year
- Farebox Recovery Ratio:
