

### **Update on Joint Short-Range Transit Plan**

- Agreement executed with LSC Transportation Consultants
- Conducted on-vehicle passenger surveys week of October 23-27

#### **Finance and Administration**


- 30% price increase for battery-electric buses see Agenda Item C-2
- Received reimbursement for all necessary repairs caused by President-declared flood disaster



# **Ridership Results**

- RTA fixed-route ridership increased 5.3 % over last year
  - Still 40.2% less than pre-pandemic totals
- Runabout ridership increased 28.0% over last year
- Past five years of ridership and productivity trends are on graphs B-1-9





### **Financial Results**

- Year-to-date operating costs for FY23-24 slightly below budget (15.6% through 16.7% of budget year)
- Farebox Recovery Ratios:
  - Fixed-Route 8.5%
  - Runabout 2.8%
- Subsidy per passenger-trip:
  - Fixed-Route \$16.26
  - Runabout \$126.91

- One adjustment to operating expenditures
- None of these adjustments require additional/new funds
- STA adjustment not included
- Note impact of GASB 68
  - This was pulled out of the farebox ratio calculation in the audit



### **Changes Overview**

- GASB 68 adjustment increase to beginning balances
- Carryover 5307 and 5339 funds
- Increase in professional technical services
- Carryover large number of vehicle projects and Short Range Transit Plan

# **Background/Discussion**

- Original Board authorization was \$5,215,200 at November 2022 meeting
  - May 2022 price was \$1,052,694.84 per bus
  - October 2023 quote is \$1,370,651 per bus
- Spare parts/training still needs to be negotiated
- Phase 1b of recharging system still needed

#### Funding shortfall of \$2,178,055
