Subject: Public Comment Acknowledging RTA's involvement with SLOCOG SLO Regional ZEB

Implementation Plan

"SLOCOG began developing the SLO Regional Zero-Emissions Bus Implementation Plan in October of 2019. Stakeholders of the Plan were identified as those affected by the Innovative Clean Transit Regulation, which mandates public transit agencies to transition their bus fleets to 100% zero-emission buses by 2040. SLOCOG invited stakeholders to participate in the development of the Plan by joining the Plan advisory group. The advisory group met periodically to review draft sections, share feedback, and discuss the progression of the Plan. The Regional Transit Authority has been an active member of the Plan advisory group. RTA Executive Director, Geoff Straw, has provided SLOCOG with numerous resources and his involvement in the development of the plan is greatly appreciated. The last advisory group meeting was held in May of 2020 to review the administrative draft Plan. This Draft Plan is currently in its revision stage.

Since May, the Draft Plan has been revised and updated. SLOCOG is holding additional review meetings with certain stakeholders, which includes RTA, to review the revised versions of the Draft Plan. All revisions are based on feedback and comments shared by attendees of the additional review meetings. To date, SLOCOG has met with SLO Transit and Monterey-Salinas Transit on June 11<sup>th</sup> and June 30<sup>th</sup>, respectively. RTA and SLOCOG plan to hold an additional review meeting to review the newest revision of the Draft Plan before finalizing it. Each additional review meeting is meant to help improve the Draft Plan toward completion. Once the Plan is finalized, it will be reviewed by the SLOCOG Board in August."
