## **Bidding Process**

- RTA Board authorized RFQ at November 2024 meeting, with a budget of \$1,359,700
- Three design-build teams submitted Statements of Qualifications; only two teams subsequently proposed a solution/price
- Neither bidder proposed a Buy America Act compliant battery-energy storage system (BESS)

# **Bidding Results**

- Electricraft, Inc. is the lowest responsible and responsive bidder at \$682,268 (with bid alternate)
- Set aside \$62,160 for future BESS project using State funds

# **Bidding Process**

- RTA Board authorized an RFQ at November 2024 meeting, with a budget of \$959,320
- Timing of project is critical, as the next five BEBs will be delivered in late 2025
- Only one design-build team submitted a Statement of Qualifications, and a subsequent solution/price proposal

# **Bidding Results**

- Electricraft, Inc. was deemed responsible and responsive, and proposed a price of \$1,005,234
- Two Options provided based on timing of FTA Section 5339b funds
