Staff to Rebid for Construction Services

SUMMARY:

The new long-term Bus Maintenance Facility (BMF) project will provide administrative, operations and vehicle maintenance functions on 6.5 acres of RTA-owned land at 253 Elks Lane in San Luis Obispo. Staff has presented the BMF project to the RTA Board of Directors many times through its various phases over the past six years – land purchase, conceptual planning, environmental review, design/engineering, and procurement of commissioning and construction management. The RTA Board authorized construction bidding at its March 4, 2020 meeting.

Following a six-week bidding period, we opened two bids from local General Contractors by the April 21, 2020 deadline. The prices bid were as follows:

- 1. Newton Construction for \$17,280,000, and
- 2. Specialty Construction, Inc. for \$18,395,000.

Specialty Construction timely filed a bid protest regarding Newton Construction's bid. One component of the protest was alleged deficiencies in Newton Construction's compliance with DBE requirements. Although Newton Construction did not timely protest Specialty Construction's bid, it subsequently alleged similar deficiencies in Specialty Construction's bid. RTA staff evaluated the bid protest and subsequent correspondence and met with all interested parties. Based on this review, RTA staff recommends that the Board reject all bids in accordance with Section 8.1 [inadvertently labeled 7.1] of the RFP and authorize staff to rebid the project to allow all bidders to resolve the alleged discrepancies in their respective bids. Although delaying contract award essentially puts the project behind by roughly two months and the RTA will incur additional lease payments and bidding costs, staff believes it is in the RTA's best interests to reject both bids and rebid the project given the nature of the dispute and the need for compliance with federal DBE requirements.

If the RTA Board authorizes rebidding the project, staff would advertise the bidding documents later today. State law requires a minimum 10-day bidding period. Due to the Memorial Day holiday and other factors, staff is recommending a bid closing date of Thursday June 4, 2020 at 2:00PM. Other pertinent dates related to rebidding would be as follows:

- Deadline for potential bidders to submit Requests for Information Thursday May, 28, 2020 at 3:00PM. Addendum #1 would be posted by Monday June 1, 2020 at 5:00PM.
- 2. Deadline to submit follow-up subcontractor information Friday June 5, 2020 at 2:00PM.
- 3. Deadline to submit DBE Letters of Intent Tuesday June 9, 2020 at 2:00PM.
- 4. Deadline to submit a bid protest Thursday June 11, 2020 at 5:00PM.
 - a. If a bid protest is submitted, the protested firm would be required to submit its written rebuttal to the RTA Executive Director by 2:00PM on Monday June 15, 2020.
 - b. The informal bid protest hearing would occur on Wednesday June 17, 2020 at 10:00AM. The RTA Executive Director would issue the agency's findings by 5:00PM on Friday June 19, 2020.
 - c. Affected bidders could submit a request for Administrative Reconsideration within five business days after the findings report is issued, and the Administrative Reconsideration hearing would occur on Tuesday June 30, 2020 at 10:00AM.

RTA Board would award of the construction contract and financing of the project at its July 8, 2020 meeting.

Staff Recommendation

Reject both April 21, 2020 bids, and direct staff to rebid for construction services according to the timeline presented in the Staff Report.
